DEFENSIVE DRIVING REQUIREMENTS AND INSTRUCTIONS

You may be able to require that this charge be dismissed by successfully completing a driving safety course or motorcycle operator training course if you were cited while operating a motorcycle. You will lose that right if, on or before your appearance date, you do not provide the court with notice of your request to take the courts and there are no extensions.

The following items must apply to you in order to complete defensive driving for the dismissal of your ticket.

- I possess a valid Texas Driver's License and DO NOT hold a Commercial Driver's License (CDL).
- I am not taking, and have not completed a driving safety course during the past 12 months.
- I am not charged with speeding 25 MPH or more over the posted speed limit
- I was not charged with speeding in a construction zone with worker's present
- I was not charged with speeding in a School Zone.

If you choose to complete defensive driving for the dismissal of your ticket you must notify the court in writing with this notarized form by the date you are cited to appear. You will then have 90 days to supply the court with the following items:

- Payment of the court fee for defensive driving which can be obtained by calling the JP office.
- A copy of your driving record type 3a (www.texas.gov).
- A copy of your proof of financial responsibility.
- A copy of your certificate of completion from a TEA approved Defensive Driving Course. You must send the actual signed original copy of that certificate.
