## NOTICE OF PUBLIC HEARING ON TAX **INCREASE**

A tax rate of \$.61473 per \$100 valuation has been proposed by the governing body of San Jacinto County.

The no-new-revenue tax rate is the tax rate for the 2020 tax year that will raise the same amount of property tax revenue for San Jacinto County from the same properties in both the 2019 tax year and the 2020 tax year.

The voter-approval tax rate is the highest tax rate that San Jacinto County may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that San Jacinto County is proposing to increase property taxes for the 2020 tax year.

A public hearing on the proposed tax rate will be held on: Thursday, September 24, 2020 at 9:00 am at the San Jacinto County Shelter located at 225 Live Oak, Coldspring, TX 77331.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, San Jacinto County is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the San Jacinto County of San Jacinto County at their offices or by attending the public meeting mentioned above.

The 86th Texas Legislature modified the manner in which the voter-approval tax rate is calculated to limit the rate of growth of property taxes in the state.

## **Indigent Defense Compensation Expenditures**

The San Jacinto County spent \$390,574 from July 1, 2019 to June 30, 2020to provide appointed counsel for indigent individuals, less the amount of state grants received by the county. In the preceding year, the county spent \$377,678 for indigent defense compensation expenditures. The amount of increase above last year's indigent defense expenditures is \$12896. This increased the voter-approval rate by \$ .00068 /\$100 to recoup the increased expenditures.
