### **PUBLIC HEARINGS ON FY 2024-2025 TAX RATE MEETING TO ADOPT BUDGET AND VOTE TO SET TAX RATE**

THE PROPOSED BUDGET WILL RAISE MORE TOTAL PROPERTY TAXES THAN LAST YEAR'S BUDGET BY \$1,111,272.00 (OR 8.29%) AND OF THAT AMOUNT \$492,965 IS TAX REVENUE TO BE RAISED ON NEW PROPERTY ADDED TO THE TAX ROLL THIS YEAR. A TAX RATE OF \$0.50776 PER \$100 VALUATION HAS BEEN PROPOSED BY THE GOVERNING BODY OF SAN JACINTO COUNTY.

PROPOSED TAX RATE: \$0.50776 PER \$100  
NO-NEW-REVENUE TAX RATE: \$0.48071 PER \$100  
VOTER-APPROVAL TAX RATE: \$0.50776 PER \$100

THE NO-NEW-REVENUE TAX RATE IS THE RATE FOR THE 2024 TAX YEAR THAT WILL RAISE THE SAME AMOUNT OF PROPERTY TAX REVENUE FOR SAN JACINTO COUNTY FROM THE SAME PROPERTIES IN BOTH THE 2023 TAX YEAR AND THE 2024 TAX YEAR.

THE VOTER-APPROVAL RATE IS HIGHEST TAX RATE THAT SAN JACINTO COUNTY MAY ADOPT WITHOUT HOLDING AN ELECTION TO SEEK VOTER APPROVAL OF THE RATE.

THE PROPOSED TAX RATE IS GREATER THAN THE NO-NEW-REVENUE TAX RATE. THIS MEANS THAT SAN JACINTO COUNTY IS PROPOSING TO INCREASE PROPERTY TAXES FOR THE 2024 TAX YEAR.

THE PROPOSED TAX RATE IS GREATER THAN THE VOTER-APPROVAL TAX RATE. AS A RESULT, SAN JACINTO COUNTY IS NOT REQUIRED TO HOLD AN ELECTION AT WHICH VOTERS MAY ACCEPT OR REJECT THE PROPOSED TAX RATE. HOWEVER, YOU MAY EXPRESS YOUR SUPPORT FOR OR OPPOSITION TO THE PROPOSED TAX RATE BY CONTACTING THE MEMBERS OF THE SAN JACINTO COUNTY OF SAN JACINTO COUNTY AT THEIR OFFICES OR BY ATTENDING THE PUBLIC HEARING MENTIONED ABOVE.

YOUR TAXED OWED UNDER ANY OF THE RATES MENTIONED ABOVE CAN BE CALCULATED AS FOLLOWS:  
PROPERTY TAX AMOUNT = (TAX RATE) X TAXABLE VALUE OF YOUR PROPERTY/100.
