RESOLUTION AND ORDER CALLING FOR A SPECIAL ELECTION ON THE ISSUE OF THE CREATION OF SAN JACINTO COUNTY EMERGENCY SERVICES DISTRICT NO. 2 PURSUANT TO CHAPTER 775, HEALTH & SAFETY CODE TO BE HELD ON NOVEMBER 5, 2024

WHEREAS, pursuant to Chapter 775, Texas Health & Safety Code, the Commissioners Court of San Jacinto County granted the petition (“Petition”) filed for the creation of the proposed San Jacinto County Emergency Services District No. 2 (“District”) and ordered a special election on same to be held on November 5, 2024; and,

WHEREAS, the Commissioners Court of San Jacinto County (“Court”) held a meeting called and conducted pursuant to all applicable law, including the Texas Open Meetings Act, on August 7, 2024; and,

WHEREAS, the Court ordered the San Jacinto County Elections Administrator to take all necessary actions to conduct said election in conformance with applicable law; and,

WHEREAS, at its meeting held on August 7, 2024, San Jacinto County (“County”) ordered such an election pursuant to Chapter 775, Health & Safety Code, and other applicable law, to be held on November 5, 2024:

NOW, THEREFORE, BE IT RESOLVED AND ORDERED BY THE COMMISSIONERS COURT OF SAN JACINTO COUNTY, TEXAS THAT:

Section 1. That the statements contained in the preamble to this Resolution and Order are true and correct and are adopted as findings of fact and law hereby.

Section 2. San Jacinto County, Texas shall hold a special election on November 5, 2024 between the hours of 7:00 a.m. and 7:00 p.m. at the polling locations and precincts common to the proposed District and set forth and established by the San Jacinto County Commissioners Court, or as otherwise determined by applicable law, with all applicable early and absentee voting places determined by the Court in conjunction with other elections to be held on that day by the County. The location of the main early voting by personal appearance polling place shall be those locations as designated by the San Jacinto County Elections Administrator, pursuant to applicable law. The County’s Early Voting Clerk shall be Cheri Walker, San Jacinto County Elections Administrator, or designee, whose official mailing address is 51 East Pine Avenue, Coldspring, Texas 77331. The County’s Election Official is Fritz Faulkner, County Judge of San Jacinto

County, Texas, whose official mailing address is 1 State Highway 15, Room 23, Coldsping, Texas 77331. The Election Official is hereby empowered to execute any and all necessary documents and take any and all necessary actions to conduct the election ordered herein. The Presiding Election Judges and the Alternate Election Judges shall be those as designated by the San Jacinto County Elections Administrator.

Section 3. The early voting shall be held as designated by the San Jacinto County Elections Administrator or the Court at those locations and times to be determined.

Section 4. Pursuant to Texas Election Code, the County adopts and designates the precincts of San Jacinto County located within the proposed District's territorial limits as set out in the Petition as its precincts for this election, and as may be determined by the San Jacinto County Elections Administrator. The County shall follow all applicable bilingual procedures in the election. The County may consolidate some of these precincts upon the advice of the San Jacinto County Elections Administrator and pursuant.

Section 5. The voting at said election shall be by voting systems utilized by San Jacinto County, and such ballots for the election shall be printed in English and Spanish to permit voting for or against the proposition:

“Confirming the creation of San Jacinto County Emergency Services District No. 2 and authorize the imposition of a tax not to exceed the rate allowed by Section 48-e, Article III, Texas Constitution.”

Section 6. The appropriate officers of the County, and its attorney, are hereby authorized and directed to coordinate and oversee this election, and the San Jacinto County Elections Administrator, and its appropriate officers, is hereby appointed to assist the County in the coordination and oversight of this.

Section 7. Notice and/or Order of this election, in substantially the form promulgated by the Texas Secretary of State or other applicable law, and in Spanish translation thereof, shall be issued and given in the manner provided by law.


Section 8. The County reserves the right to amend this order as necessary to conduct this election pursuant to applicable law and in compliance with the San Jacinto County Elections Administrator or other appropriate authorities having jurisdiction.




